## **Dredging has begun! We need more donations!**

Sediment is now being pumped to the dewatering basin at the Halquist North Lake pit. Dredging operations will continue 24 hours a day, 6 days per week until we run out of money or the job is done.

NLMD has received the approved DNR permit for Schneider Bay and the additional cubic yards in Ice House bay. All we need now is the money to complete the whole job. We have put in a tremendous amount of work to get to this point, let's push this project over the finish line! Please review the donation suggestions in this email to help us reach our goal.

**We need \$269,076 more to be able to finish the entire project.**

**Donation Deadline, October 10.**

If we don't raise all of the required funds for the project, the NLMD commissioners in consultation with the Environmental & Water Quality committee, will be forced to make a decision on which areas of the lake will not be dredged. The decision will be made in October. Please send in your donations ASAP so we can plan for the most efficient and cost-effective way to complete the project.

### Donation Suggestion

If you live in the area to be dredged: \$5,000 minimum

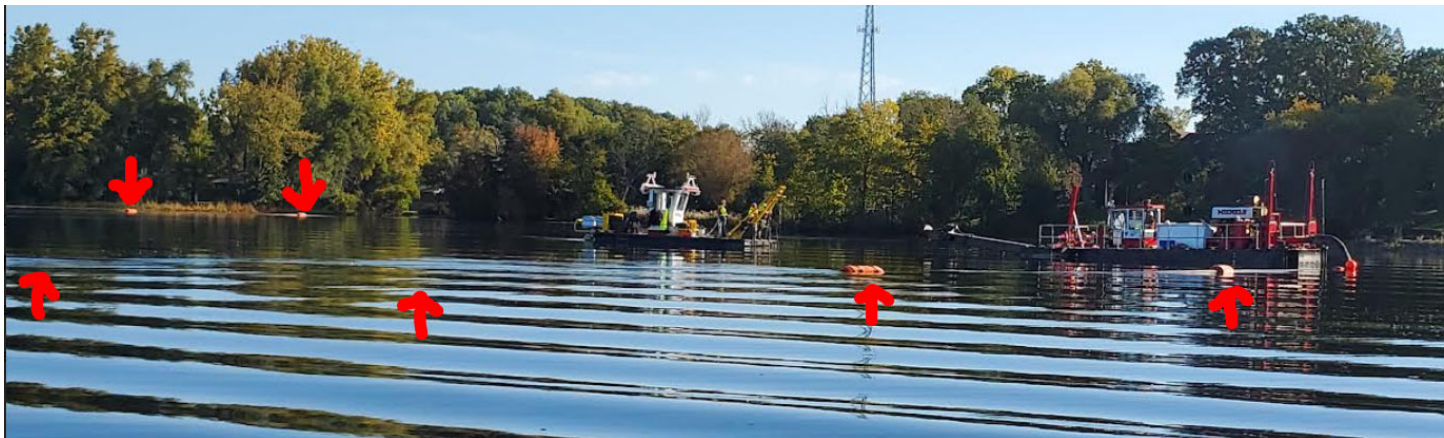
If you have already donated \$5000, any more that you can donate would be greatly appreciated!!!

If you live outside of the area to be dredged: \$2,500 minimum

If everyone follows the suggestion, we will have enough to dredge all of the identified sediment out of the North bays.

### Using the lake during the Dredging Process

- Avoid the area being dredged
- Do not attempt to cross the pipeline
- The pipeline will be floated immediately behind the dredge. The rest of the pipeline will spend the majority of time on the bottom as it will be full of sediment.



- The pipeline will be floated now and again to add or remove sections or move the dredge.
- The pipeline will be marked every 100' or so with buoys to identify the location when underwater.
- You will need to go around the dredge pipeline if using the NLYC launch site while dredging is taking place
- Do not attempt to cross the pipeline – if you must cross, flag down the dredging support boat for assistance
- The dredge is not able to move out of your way
